Prime Minister officiates Khazanah Americas Incorporated office

- KAI to facilitate Malaysian strategic investments in the Americas

The establishment of KAI will help build a pipeline of talent and collaboration between Malaysia and the US and help accelerate Malaysia's very own innovation and technology capabilities."

In this, Tan Sri Azman added: "KAI will play an immensely important role as a bridge between Malaysia and the premier innovation and technology hubs of the US."

Khazanah's expansion into the American continent is part of its larger strategy to become more global in scope. As of 29 May 2013, Khazanah's overseas investments represent approximately 9% of its total investments portfolio of RM135.9 billion. On a see-through basis, the percentage is bigger and represents approximately 35% of Khazanah's investments portfolio.

At the same event, Khazanah was also conferred the Global Award for Visionary Innovation Leadership by Frost & Sullivan, the global business consulting firm, for the pioneering work that Khazanah has done to catalyse and propel economic development in Malaysia.

The prestigious award acknowledges Khazanah's leadership role in transforming Government-Linked Companies (GLCs), expanding the Malaysia brand regionally and globally, and its visionary approach to economic development through Iskandar Malaysia.
