Dato' Amirul was previously Executive Vice President, Special Projects at Permodalan Nasional Berhad (“PNB”) in 2010, and Managing Director, Head of Investment Banking at Maybank Investment Bank Berhad from 2008 to 2010, where he was responsible for the investment banking, corporate finance, equity capital markets and venture capital divisions. He has also served as Executive Director at Binafikir Sdn Bhd, as well as in various management capacities at Citigroup Global Markets (Asia) Ltd, Salomon Smith Barney, Schroders, and KPMG.

Dato' Amirul is a Chartered Banker, Asian Institute of Chartered Bankers, Member of the Malaysian Institute of Accountants, and Fellow of the Institute of Chartered Accountants England and Wales. He holds a Bachelor of Science in Economics (Accounting and Finance) from the London School of Economics.
